Board Meets in Chicago

ANA officers consider finance, conventions and strategic plan.

➤ THE ANA BOARD of Governors met in open and executive sessions in conjunction with the American Numismatic Association's World's Fair of MoneySM at the Donald E. Stephens Convention Center in Rosemont, Illinois, August 5-9. Present and voting were President Walter A. Ostromecki Jr., Vice President Jeff Garrett, and Governors Gary Adkins, Mike Ellis, Greg Lyon, Ralph Ross, Scott Rottinghaus, Laura Sperber and Jeffrey Swindling. (Vice President Jeff Garrett was absent for a portion of the proceedings.) Also present were ANA Executive Director Kimberly Kiiick, General Counsel Hollie Wieland, Treasurer Gerome Walton, Secretary Sanford Pearl, Parliamentarian Mark Lighterman, Outgoing ANA Board Youth Intern Katie Reinders, Incoming ANA Board Youth Intern Hannah Powell and Controller Carol Shuman. Resolutions

Motion by Ellis, second by Ross, to adopt the Resolution Committee's report as presented.

Donations

Motion by Ellis, second by Rottinghaus, to accept an anonymous donation of coins to the Edward C. Rochette Money Museum. Valued at approximately \$100,000, the coins will be sent to Numismatic Guaranty Corporation, the ANA's official grading service, for authentication and grading. The Museum collection assets will be adjusted accordingly.

Colloquy: The ANA Policy Manual states that any proposed donation of cash or material worth \$10,000 or more is subject to review and approval by the Board.
