# Agenda Item #3. Proposed Revisions to ANA Policy Manual – Executive Assistant Donna Nunez

The following proposed revisions to the ANA Policy Manual are corrections to inconsistent drafting; these revisions do not alter existing policies.

### Club Life Membership

In an October 2011 Bylaws revision, the membership classification known as Club Life Membership was eliminated. Current Bylaws state that only pre-existing Club Life Members are permitted to keep the classification. (Article I: Members – Eligibility, Rights & Privileges; Section 6. Club Members, Subsection b.) The Policy Manual was not updated accordingly; thus, we propose to remove the reference.

(240409 OS #3A) MOTION by Vice President Lighterman, second by Governor Sammut to remove the Life Club Membership tier from the ANA Policy Manual, consistent with the ANA Bylaws.

Vote Passed 9-0-0 Awards Policies

The term "restricted endowment" occurs in the Awards Policies section of the Policy Manual three times (under the Krause, Clain-Stefanelli, and Forman awards). In August of 2023, the Board of Governors made a motion specific to the Krause Award's fund designation to change its description from "endowment" to "temporarily restricted assets." The Clain-Stefanelli and Forman awards were also inaccurately described as "endowments," thus we propose to update all three of these award fund descriptions in the policy manual to "net assets with donor restrictions."

(240409 OS #3B) MOTION by Governor Garrett, second by Governor Heinrich to change the fund descriptions of the Chester Krause Memorial Distinguished Service Award, the Elvira Clain-Stefanelli Award for Achievement in Numismatics, and the Harry J. Forman Dealer of the Year Award to be classified as "net assets with donor restrictions" in compliance with Accounting Standards Update (ASU) 2016-14.

The Board of Directors for the Anti-Counterfeiting Educational Foundation (ACEF) has requested support for its mission to protect the integrity of U.S. and world coinage by educating officials on the economic impact and growing threat of counterfeit circulating, collectible, and bullion coins. The ANA has given supporting gifts in the past (\$5,000 in 2018 and \$55,000 in 2019) to ACEF.

# Agenda Item #6. Discussion of FIDEM 2027 – Executive Director Kim Kiick & Museum Director/Curator Doug Mudd

FIDEM, the International Art Medal Federation, was established in 1937. Its aims are to promote and diffuse the art of medals at international level, to make the art known and to guarantee recognition of its place among other arts by increasing awareness of the art, history and technology of art medals, mainly

through publications and the organisation (sic, international spelling) of international events. FIDEM also organises (sic, international spelling) a congress every two years and an international exhibition of the art of medals in order to promote exchanges among artists and to make their work known internationally.

The ANA hosted the FIDEM Congress in 1987 and 2007. We have been approached to consider hosting the 2027 FIDEM Congress.

**Discussion:** Executive Director Kiick and Museum Director/Curator Mudd provided the background on past ANA involvement in the Congress and details on the current request from FIDEM.

Governor Brush commented that the effort took too much staff time and questioned if the effort was justified this time.

President Uram asked if there were any other organizations we could partner with to host the Congress.

Museum Director/Curator Mudd advised that ANS had not accepted the FIDEM request prior to FIDEM asking the ANA.

Executive Director Kiick indicated that her major concern is the staff time to host the Congress and the fewer staff available to perform all the tasks, especially dealing with U.S. Customs, associated with the event.

Governor Mitchell advised that he did not support hosting the event.

President Uram then opened the meeting to the people attending the Zoom meeting for any comments. There were none.
